REQUIREMENTS FOR BASIC FIRE EXTINGUISHER COMPETENT PERSON COURSE

- 1. A Malaysia Citizen
- 2. Age between 18 65 years old
- 3. Minimum educational qualification Pass SPM or equivalent
- 4. Physically & mentally fit
- 5. Has attend Fire Extinguisher Course
- 6. Pass two [2] years working experience in servicing portable fire extinguisher
- 7. Possess sufficient knowledge and skill in servicing of portable fire extinguisher
- 8. Participants must bring their own safety equipments (goggle, face mask, glove, and safety boots)
- 9. Participants must bring the following documents for verification purpose :
 - Identity card
 - SPM certificate or equivalent
 - Certificate of Companies Commission Of Malaysia (SSM)/ Form 9 & 49/ Business Registration Certificate (including attachment information current business owner) if the participant is the owner of the company OR
 - Certificate of Registration of Employer (KWSP 19)/ latest (3) months EPF contribution by the employer, latest (2) years EPF Member's Account Statement if participant is not the owner of the Company.
- 10. Candidates who failed in the examination (theory and/ or practical) will be allowed to repeat the examination within two (2) years.

^{*}Please note there is a minimum requirement of 40 participants registered per session in order for the exams to run. If the minimum number of requirement participants is not met for a specific date those registered will be automatically added to the next available course date.

BASIC FIRE EXTINGUISHER COMPETENT PERSON

- The Participant must a least has passed Sijil Pelajaran Malaysia (SPM) and other academic qualification that equivalent to Diploma / Bachelor Degree. The original of the certificates must be presented during the registration.
- The Participant must be a competent person and possess at least two (2) years of working experience in servicing and maintaining portable fire extinguishers. The interpretation of competency is to be determined by the employer and the participant.
- Supporting documents required to be presented for verification during the registration are i) Company registration form (SSM) Form 9 and Form 49 if the participant is the owner of the company; or ii) Employer's Certificate of Registration (KWSP 19), the latest 3 months of Employer's EPF Statement AND the latest two years of Employee's EPF Statement if the participant is NOT the owner of the company
- ➤ If the participant is incompetent and inexperienced in handling a fire extinguisher, but willing to participate, he / she can still register and attend the curse. Nevertheless, they have to bear the risks and consequences of falling test (theory and practical). In addition, the participant may encounter difficulties registering as a Competent Person with Fire and Rescue Department Malaysia (FRDM), because an experience in APA's maintenance is one of the criteria accounted in the registration. Thus, we will not be held responsible for the unsuccessful registration.
- The age of participant must between 18 to 65 years old only. Nevertheless, a person who is more than 65 years old maybe accepted provided the application is accompanied with a medical approval from the Government Medical Officer. This is to certify that the participant can safely carry out extensive physical activities under this course.
- ➤ Pregnant or suspected pregnant ladies should not participate in this course.
- The participant must be capable of reading and writing in Bahasa Melayu and English.
- ➤ Participants must bring their own Personal Protective Equipments including safety shoes, goggle, mask and gloves during the course.
- Fees for this 'Basic Fire Extinguisher Competent Person Course is RM1000.00 for Course Fee and RM200.00 for the Exam Fees (all fees are including food and beverage but **NOT** include accommodation).
- Candidates who failed in the examination will be allowed to repeat the exam in the upcoming courses available, which the Repeating Exam fees of RM120(Theory) and RM 230 (Practical) will be imposed.
